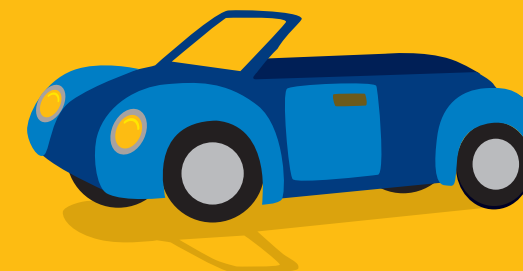
1. Ivverifika l-ammont tal-liċenzja minn fuq L-Avviż ta' Tiġdid jew żur is-sit www.licenzji-vetturi.gov.mt.
2. Ivverifika jekk għandek xi multi u zid l-ammont mal-pagament tal-liċenzja. Żur is-sit tal-*Local Enforcement System* - www.les.gov.mt.
3. Ivverifika jekk għandek xi kontijiet pendenti tal-*Controlled Vehicular Access (CVA)* u zid l-ammont mal-pagament tal-liċenzja. Cempel lill-*Controlled Vehicular Access Helpdesk* fuq in-numru 2206 4000 jew cempel lil *Transport Malta* fuq in-numru 8007 2309, jew żur is-sit www.cva.gov.mt jew www.maltatransport.com rispettivament.
4. Imla l-**Formola tal-Ħlas tal-Liċenzja** li ssib f'dan il-fuljett biex tagħtina l-kunsens li nġeddulek il-liċenzja u ibghatha flimkien mal-**Formola tal-Ħlas tal-Assigurazzjoni** u l-pagament (INHEĠĠUK TAQRA N-NOTI IMPORTANTI LI HAWN F'DAN IL-FULJETT).

AHNA NIBAGHTULEK IL-LIĊENZJA TAT-TRIQU U Ċ-ĊERTIFIKAT TAL-ASSIGURAZZJONI BIL-POSTA.

NOTI IMPORTANTI

1. Ftakar li dan huwa servizz B'XEJN li qed jiġi offrut lilek. Dan is-servizz nistghu noffruh bis-saħħa ta' *computer link* li għandna mal-*Licensing and Testing Department (LTD)*, li ahna m'għandniex kontroll fuqha. Jista' jkun għalhekk, li ma nkunux nistghu nġeddu l-liċenzja tal-vettura tiegħek għal raġunijiet li ma nkunux nafuhom, u f'dak il-każ ikun meħtieġ li inti tmur direttament għand l-LTD. Jekk tingala' din il-problema ahna ninfurmawk immedjatament.
2. Għalkemm ahna naghmlu l-almu tagħna biex nġeddu l-liċenzji mill-aktar fis hekk kif jaslu għandna, dan kollu jiddependi mis-servizz postali u għalhekk ma nistghu noffru l-ebda garanzija li l-liċenzja tat-triqu tasal għandek qabel l-ahhar tax-xahar, speċjalment jekk il-formola tal-ħlas tasal għandna wara l-20 tax-xahar. F'dan il-każ ahna m'ahniex responsabbli jekk inti tehel xi kontravvenzjoni.
3. Hlas għat-tiġdid tal-liċenzja jista' jsir biss permezz ta' *Credit Card* jew *Debit Card*. Mhux aktar possibbli li thallas permezz ta' ċekk u għalhekk jekk tibghat ċekk ma nkunux nistghu nipproċessaw it-talba tiegħek. M'għadux aktar possibbli li tohroġ ċekk f'isem **Transport Malta** għax m'għadhomx jiġu aċċettati.
4. Jekk il-Formola tal-Ħlas tal-Liċenzja ma tkunx mimlija kollha ma nkunux nistghu nġeddu l-liċenzja.
5. Jekk jinqalghu xi problemi relatati mat-transazzjoni li ssir fuq id-*Debit Card* jew fuq il-*Credit Card* ikun meħtieġ li inti tikkuntatta l-bank tiegħek direttament.
6. It-termini u l-kundizzjonijiet tal-bank tiegħek japplikaw għal kull transazzjoni li ssir b'*Debit* jew *Credit Card*.
7. Jekk wara li tkun għamilt il-VRT inharġitlek **Discrepancy Form**, il-liċenzja **MA TISTAX** tiġi mġedda permezz tal-*Computer Link*. Ikollna naghmlu użu minn servizz ieħor ta' tiġdid li jirrikjedi li nibagħtu t-talba tiegħek lil-LTD kif kien isir s'issa. F'dawn il-każijiet biss nitlobuk tohroġ ċekk pagabbli lil **Transport Malta** flimkien mad-*Discrepancy Form* originali u l-*Log book*. Nixtiequ nfakkruk li f'dawn il-każijiet il-proċess tat-tiġdid tal-liċenzja jista' jdum aktar.

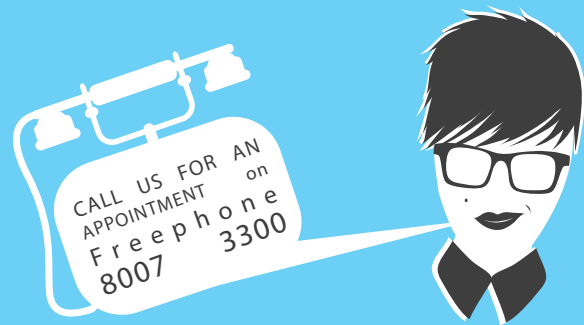

PAYING YOUR ROAD LICENCE

You can ask us to renew the road licence for you together with the renewal of your motor insurance policy. All you need to do is the following:

1. Check licence fee on your Renewal Notice or visit the website www.licenzji-vetturi.gov.mt
2. Check for any pending contraventions and add amount to your licence fee. Visit the Local Enforcement System website www.les.gov.mt.
3. Check for any pending CVA (Controlled Vehicular Access) bills and add amount to your licence fee. Call the CVA Helpdesk on tel. 2206 4000 or Transport Malta Customer Care on Free Phone 8007 2309, or visit the websites www.cva.gov.mt or www.maltatransport.com respectively.
4. Complete the attached **Licence Renewal Payment Form** authorising us to renew your road licence, and forward it to us with your renewal instructions and payment (SEE IMPORTANT POINTS BELOW).

WE WILL SEND YOU THE ROAD LICENSE TOGETHER WITH YOUR MOTOR INSURANCE CERTIFICATE BY MAIL.

IMPORTANT POINTS

1. Please remember that this is a FREE service that is being offered to you. To offer this service we rely on a computer link with the Licensing and Testing Department (LTD) over which we have no control. This may mean that we will be unable to process the renewal of your licence for reasons unknown to us and you will then need to do this directly with the LTD. If this is the case we will inform you as soon as we become aware of the problem.
2. Although we will do our utmost to process licence renewals as soon as when we receive them, we do rely on the postal service for delivery and therefore we cannot offer any guarantee that your road licence will be delivered to you before the end of the month. This is particularly the case if we receive your renewal instructions after the 20th of the month. We therefore cannot accept any claims for compensation for fines that you may incur.
3. Payments for the renewal of the road licence can ONLY be accepted by means of a Credit Card or Debit Card. Payments by cheque are NOT possible and cannot be processed on the online system. **Please DO NOT send cheques payable to Transport Malta as these can no longer be used to pay your licence.**
4. We will not be able to process your licence renewal if you do not complete IN FULL the Licence Renewal Instruction Form.
5. If your Debit/Credit Card transaction fails, you will need to contact your bank.
6. All debit/credit card transactions are subject to the terms and conditions issued by the bank.
7. If after the VRT you were issued with a **Discrepancy Form**, your licence **CANNOT** be renewed through the on-line service. We can forward your licence payment to the Licensing & Testing Directorate on your behalf. In these cases ONLY please send a separate cheque payable to "Transport Malta" to pay for the road licence together with the original Discrepancy Form and your log book. Please remember that in these cases the renewal process may take longer.
